
The zone area "Gornje Mekušje" covers the area of 104,616 m². The entire zone area is in the ownership of the Town of Karlovac. The zone is divided into 10 building plots, and building plots no. 8 - 10 can be joined together.

PROJECT AIMS

Project aims are focused on the activation of the available area of the zone Gornie Mekušie aimed at entrepreneurs for performing entrepreneurial activities within the entrepreneurial zone, equipped and constructed infrastructure of the zone and populating the zone with companies which will operate in the zone. The project results will be reflected in the total of 8.225 m² of equipped and constructed infrastructure of the zone, i.e. built roads, energy, sewage, water supply, communication and the so-called green infrastructure, the number of companies operating in the zone and, consequently, increase of their competitiveness, creation of new workplaces, stimulation of new investment by entrepreneurs and transfer of knowledge and innovations.


The Town of Karlovac is situated in central Croatia. With a population of



The most significant economic activities are manufacture, trade and construction, and the preserved nature and numerous cultural and historical monuments make a good basis for the development of the tourist sector.

ZONE POSITION

The entrepreneurial zone Gornje Mekušje is situated in Karlovac, near main state highways and railway lines. A modern highway (39km) connects Karlovac with Zagreb (international airport) and Rijeka (133km, seaport).



AREA PURPOSE AND ZONE PLOT SUBDIVISION PLAN

The entrepreneurial zone Gornja Mekušje is a part of the space of the Town of Karlovac which has been intended for the development of entrepreneurship by spatial planning documentation. Construction in the zone should be done in accordance with the Urban plan "Business zone Mekušje-I stage". For (I) and (K) purpose, maximum total construction coefficient of building plot (Kig) is 0.60, and the minimum 0.1. Maximum allowed number of floors is E=5.
